



## **CAWL MINIMUM AGE RESTRICTION WAIVER RELEASE AND INDEMNIFICATION AGREEMENT**

**The CAWL Weight Classes and Age Restrictions are as follows:**

### **MAXIMUM AGE RESTRICTIONS:**

- In the 50 pound weight class, a wrestler cannot be ten (10) on or before December 31
- In the 55 pound weight class, a wrestler cannot be eleven (11) on or before December 31
- In the 60 pound weight class, a wrestler cannot be twelve (12) on or before December 31
- In the 65 & 70 pound weight class, a wrestler cannot be thirteen (13) on or before December 31
- In the 75 & 80 pound weight classes, a wrestler cannot be fourteen (14) on or before December 31
- In the 85 & 90 pound weight classes, a wrestler cannot be fifteen (15) on or before December 31
- In the 95 through 200 pound weight classes, a wrestler cannot be sixteen (16) on or before December 31

### **MINIMUM AGE RESTRICTIONS:**

**THE FOLLOWING APPLY TO THE WEIGHT CLASSES LISTED, UNLESS WAIVED IN WRITING BY A PARENT OR LEGAL GUARDIAN**

- In the 95 pound weight class, a wrestler must be nine (9) or older on or before December 31
- In the 100 & 105 pound weight classes, a wrestler must be ten (10) or older on or before December 31
- In the 110 through 122 pound weight classes, a wrestler must be eleven (11) or older on or before December 31
- In the 130 through 200 pound weight classes, a wrestler must be twelve (12) or older on or before December 31

The undersigned wrestler (“Participant”) seeks to be allowed to participate in CAWL sanctioned events in a weight class for which Participant’s age is below the minimum age restriction set forth herein. Participant, through his/her parent(s) and/or legal guardian(s), hereby seek a waiver of the minimum age restrictions of the CAWL, (“Waiver”) such that Participant may be allowed to participate in CAWL sanctioned events in a weight class for which Participant’s age is below the minimum age restriction set forth herein.

In consideration of the Waiver requested, Participant, through his/her parent(s) and/or legal guardian(s), authorized representatives, agents, successors, administrators, and assigns, do hereby irrevocably and unconditionally releases the CAWL and its affiliated clubs, and their respective officers, administrators, coaches, trainers, meet coordinators, referees, sponsors, sponsoring agencies and advertisers, or the owners and lessors of premises in which such events occur, with respect to any and all claims, damages, causes of action or other liabilities arising out of the Participant’s injury or death occurring during such events, arising during the course of competition and or related in any manner to a CAWL sanctioned event.

As further consideration for the granting of the Waiver, the Participant and his/her parent(s) and/or legal guardian(s), authorized representatives, agents, successors, administrators, and assigns, hereby agrees to indemnify and save harmless the CAWL and its affiliated clubs, and their respective officers, administrators, coaches, trainers, meet coordinators, referees, sponsors, sponsoring agencies and advertisers, and the owners and lessors of premises in which such events occur, with respect to any and all claims, damages, causes of action or other liabilities

arising out of the Participant's injury or death occurring during such events, arising during the course of competition and or related in any manner to a CAWL sanctioned event, including, but not limited to, costs and attorney's fees.

The Participant, through his/her parent(s) and/or legal guardian(s), authorized representatives, agents, successors, administrators, and assigns, hereby covenants not to sue the CAWL and its affiliated clubs, and their respective officers, administrators, coaches, trainers, meet coordinators, referees, sponsors, sponsoring agencies and advertisers, and the owners and lessors of premises in which such events occur, with respect to any and all claims, damages, causes of action or other liabilities arising out of the Participant's injury or death occurring during such events, arising during the course of competition and or related in any manner to a CAWL sanctioned event.

The undersigned hereby warrants, represents, and acknowledges having adequate health insurance necessary to provide and pay for any medical costs that directly or indirectly result from any and all participation in CAWL sanctioned events, and a current USAW card for supplemental insurance. Each of the undersigned acknowledges the sport of wrestling involves severe physical exertion and intense stress, which can result in serious injury or in some rare circumstances, death; he/she agrees to assume the risks of such consequences. This Waiver and Release is freely and voluntarily given with full understanding of the inherent risks of participating in the CAWL's athletic competitions.
